1	Alighting From Coaches. Slipping, tripping, falling, injury from other vehicles.	1	3	3	No	Coaches should use designated coach alighting points in the car park adjacent to the cricket field. On alighting children should be adequately supervised. Supervising adults to be vigilant of moving vehicle hazards to themselves and children, and act accordingly. The group leader should then check in at the entrance, whereupon a guide will escort the group to the designated wet weather area inside the farm Park. Road speed signs erected to control vehicles to 10mph reduces potential likelihood and severity of incident. Children are to be adequately supervised see point 17.	
2	Running. Slipping, tripping, falling	2	2	4	No	Children must be adequately supervised and instructed not to run on the site. On arrival the group (Adults and children) will receive a safety talk where they are told to not run as they can fall over and hurt themselves. Children are to be adequately supervised see point 17.	
3	Uneven or slippery surfaces causing Slipping, Sprains, tripping, falling	2	2	4	No	Farm paths and natural countryside walks are uneven, can be slippery when wet / cold and tripping hazards can be present. Adults, Supervisors, and children should take care walking (not running) on the paths and grass and wear sensible footwear. Signs to make adults aware of this are positioned at the farm entrance, and the access points to the countryside walks. Advice on suitable footwear is provided in the School Information Booklet. Children are to be adequately supervised see point 17. Safety chat on arrival mentions there are uneven and slippery surfaces and for children walk with adults and to not run.	
4	Climbing of objects outside the play area causing slipping, tripping, falling OR access to unsafe areas of the farm.	2	2	4	No	Children must be adequately supervised and instructed not to climb walls, gates, and other objects outside the play area. It is also stated in the safety guidelines provided before the trip to not climb on or over fencing or gates. Children are to be adequately supervised see point 17.	

5	Animals. Infection, biting, crushing & kicking	1	4	4	No	Before the trip the group will receive safety guidelines, are directed to our 'Schools Information Booklet' and a link to the advice for teachers (part of the industry code of practise). In the School information booklet and the industry code advice for teachers, it makes teachers aware of the risks. On arrival the group is given a safety talk stressing not to put hands nears pigs, to not put hands in mouths and to wash hands before eating and again before leaving the farm. Safety guidelines are provided before the trip and are on display as you enter the farm and enter animal barns. They are also available in paper form on the day. There is also safety signage around the site. All the animals on the site are properly controlled and supervised. The farm follows the industry code of practise with regards to preventing ill health. Visitors should not touch the animals unless encouraged by Farm staff. Supervisors should ensure everyone washes their hands after visiting animal areas. There is adequate handwashing facilities. Children are to be adequately supervised see point 17.
6	Infections. Various	1	4	4	No	Supervisors should be aware that there is always a risk from infection in any environment, countryside and agricultural establishments are no exception. Information regarding this is provided in the 'Schools Information Booklet' as well in links to ' Industry code of Practices advice for teachers'. The site is run in accordance with the Industry Code of Practise. On the safety guidelines provided before the trip it states that visitors should wash their hands after touching animals and before handling food and drink and that existing cuts and abrasions are protected by a dressing. Children are to be adequately supervised see point 17.
7	Lost Children	2	1	2	No	Supervisors should instruct children of their lost person policy. The farm park is ring fenced and access on or off is restricted with the entrance shop the main way in and out which is staffed. The entrance and exit to the Farm Park is a designated waiting point for lost children.
8	Chemicals & substances Inhalation, skin contact, eye contact	1	3	3	No	All substances in use on the site are safe and free from risk when used in a proper manner. Visitors will not be exposed to risks from substances used on the site. Chemicals are stored in non-public areas or locked away.
9	Aggressive visitors	1	2	2	No	Farm staff are instructed to ensure that any aggressive visitor is removed from the site.
10	Electrical equipment. Fire, electrocution.	1	3	3	No	Electrical installations and appliances are tested and inspected at the required intervals by and independent electrical contractor. Visitors should not touch or interfere with electrical equipment. Children are supervised by their adults with them. Children are to be adequately supervised see point 17.

11	Straying into prohibited areas	1	3	3	No	Supervisors should ensure that children are instructed not to go beyond the designated area. Fencing and No entry signs on gates are erected to keep visitors out of hazardous areas. Safety guidelines provided before the trip state... ' Please keep to all paths and tracks' and 'Please do not climb on or over fencing or gates'. Children are to be adequately supervised see point 17.
12	FIRE. Inhalation, skin burns, panic, loss of control	1	3	3	No	Fire Risk Assessments have been carried out for all areas and adequate controls are in place. In case of fire, Supervisors should ensure that they and children in their care leave the building by the nearest exit and follow direction by farm staff and head to the muster point. Supervisors should ensure that a roll call is taken of their charges.
13	Water features. Drowning, panic, loss of control	1	3	3	No	Natural hazards such as streams and ponds are present in the countryside. Children should be adequately supervised and made aware of water features. Supervisors and children should take adequate precautions against slipping and falling when close to water features. Children are to be adequately supervised see point 17.
14	Animal faeces on footwear and clothing. Infection.	1	4	4	No	The walks and animal areas are arranged so that they do not overlap and allow people to walk where animals can defecate. During and after animal activities within public areas faeces is removed by the staff. Farm staff accessing animal areas/ pens walk through installed footbaths before entering public areas. Staff handling large animals are instructed to wear protective clothing when doing so and to remove protective clothing when in public areas. If footwear is soiled a disinfecting boot wash is provided by the exit. Fencing and No entry signs on gates are erected to keep visitors out of hazardous areas, such as an animal pen with faeces present or the muck heap. Safety guidelines provided before the trip state... ' Please keep to all paths and tracks' and 'Please do not climb on or over fencing or gates'. Children are to be adequately supervised see point 17.
15	Barrel Ride. Injury.	1	3	3	No	The ride is built, operated, and maintained following appropriate H&S legislation and BS EN standards. See Barrel Ride Risk assessment. What is pertinent to school group use is...There are several rules of use to ensure safety of passengers that passengers must follow. These are displayed on signage at the station of the barrel ride. They are Children under 2 must be accompanied by an adult, do not get on or off the barrels while the ride is moving, all riders must be seated within the barrels, Sit down while the ride is moving. The driver will monitor and manage passengers' behaviour, but it is also the responsibility of the adults with them manage this too. Children are to be adequately supervised see point 17.

16	Play Area	1	3	3	No	<p>The play area and equipment are built, operated, and maintained following appropriate H&amp;S legislation and BS EN standards and externally inspected quarterly by a registered play inspector. See Play Area Risk assessment. What is pertinent to school group use is... There are several rules of use to ensure safety of users that visitors must follow. These are stated on the safety sign as you enter the play area. They are - Please keep the gate closed, No Dogs allowed, Due to mixed age/ability equipment - children must be supervised at all times, Equipment is for intended use only. Higher and or more challenging pieces of play equipment have access points which are difficult to only allow children of a certain size, strength, balance, or ability to progress. Therefore, only children suitable to be at the top can pass this intended obstacle  Either, do not lift children passed these obstacles or if you do, please progress with the child to supervise them as equipment has been designed to allow adult access.  Children are to be adequately supervised see point 17.</p>	
17	Children not following safety measures/ advice, info due to not being adequately supervised	1	4	4	No	<p>It is stated on the safety guidelines provided before the trip and in the 'School Information Booklet' that adults are responsible for supervising the children with them and to ensure they &amp; themselves follow the safety guide lines, behave safely and appropriately, and follow any other safety information on site. To remove any financial obstacle of adequate supervision, group trips are permitted free adults on a ratio of 1-1 for SEN children, 1-3 for children under 5 years and 1-5 for children 5 years or over.</p>
